Presidents Report 2018-2019



Welcome everyone to the 2019 Reinforce AGM. This year has been another busy and successful one for Reinforce. We have employed 2 new project workers this year, Georgina Mills and Ellie Arthur. Ellie was hired in January thanks to the Victorian Government who provided an extra 25 percent core funding for Reinforce and other advocacy groups through their Advocacy Futures program. Ellie works on coffee mornings and helping build our membership. Ellie has also been working with us on a project about medical rights for people with an intellectual disability. The project is run in partnership with the Office of the Public Advocate and funded thanks to a grant from the Victorian Law Foundation.

Georgina was hired in July thanks to a grant from the NDIS ILC program and we have just applied for an extra three years of funding to continue the project. Thanks to both Georgina and Ellie for all the hard work they have done.

As well as the above Reinforce have also continued to work with other self-advocacy groups. In June Reinforce took part in a project run by Self-Advocacy New South Wales in partnership with the University of New South Wales.

The Self Advocacy Resource Unit have also continued to be an excellent support to Reinforce this year. Among other things they have helped us with ongoing advice, preparation for the transition to ILC and supported us to do our Strengths Weaknesses Opportunities and Threats (SWOT) analysis.

On a personal note I have continued in my role as a representative on the Victorian Government Disability Advisory Council advising government about issues for people with intellectual disabilities. I have also continued in my training role having just recently come back from a trip to Adelaide to speak

Treasurers Report by Amanda Millear

This is my 16th year as Treasurer for Reinforce I am the longest serving Treasurer in Reinforce's 32 year history.



We have received Futures funding, Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability funding and recurrent funding from the Department of Health & Human Services, Office for Disability in Victoria. We have also received funding from the Victorian Law Foundation for our joint project with OPA to develop resources for medical personnel about people with an intellectual disability and their rights. We also received funding from the NDIA ILC grant. So it has been a busy but interesting year for our volunteers and our new workers.

I would like to thank Pam for all of the hours that she has spent in supporting me with the accounts and financial records for the management committee each month, and a great big thank-you! Pam and I meet each month to discuss the finances and catering for our meetings.

I have enjoyed my time as treasurer.

Catering Co-ordinator's Report by Amanda Millear

I have been catering co-ordinator for 9 years now. Throughout the last twelve months I have been busy in my role with catering. Together with support from others I have done the ordering, collecting and paying for the food this year.

Everybody has liked the presentation of the food at the events when we have done the catering. I catered for last year's AGM. I have also ordered lunch for most of the committee meetings.

We chose the fillings for the sandwiches and everyone has enjoyed them. We have a place in the city that we regularly get our food from. This was a very well-made film and most interesting about the neon era in America and how it became like a symbol of hope for the country and how neon grew in American culture and became so popular. Lawrence Johnston is an internationally award-winning Writer, Director and Producer who began his career as a Film Repairer at 20th Century-Fox.



Our second coffee morning in July was a great success and a wonderful and enjoyable morning for all. We had Lucy Macali from DHHS – Office for Disability and Deb Rouget from Belonging Matters come and present for us and they did a fantastic presentation on the topic of: 'Employment for people with an Intellectual Disability'. They spoke about some very

good points and how it is often difficult for people with an intellectual disability to get employment and the reasons why, and some helpful tips for people with an intellectual disability in gaining employment.

ILC Project

This year Reinforce got money from the NDIS ILC program. Thanks to this money we were able to employ Georgina Mills who is working on a project to start a training unit within Reinforce. Through this program we have employed two Peer Workers. They will learn to provide training in self advocacy and rights to others with an intellectual disability

Positive Powerful Parents (PPP)

It was good to see that Positive Powerful Parents (PPP) who used to be called Powerful Parents Self Advocacy Group were successful in getting money in their own right for the first time. PPP received money through the Victorian Governments Advocacy Capacity Building program and the NDIS ILC program. This has allowed them to employ their own project worker and continue fighting for the rights of parents with intellectual disabilities.



VSAN

VSAN stands for Victorian Self Advocacy Network. This group is made up of different self-advocacy groups and together VSAN lobbies government to give a stronger voice and attention to much needed disability issues. Some of the members of VSAN are now acting as mentors to other self-advocacy groups.

Over the past 12 months VSAN have run a number of forums these forums have helped groups to get more information about the ILC grants process and have helped Reinforce to network with other Self-Advocacy groups.
