
What we have Done - Projects

ILC

This project is the Self Advocacy Training Unit (SATU) which is funded by an ILC grant from the Department of Social Services.

The project will keep going until 2023 and we do 2 main things:

- 1. Train self advocate peer workers to run training themselves
- 2. Help the organisation to grow stronger with better policies and ways of doing things.



This year we have also made new documents, brochures and training resources in easy read and plain English formats. We have changed the way the office works, welcomed new members and employed new peer workers.

The SATU Advisory Group has been very active, meeting regularly throughout the year. We thank Mark Sandon for his work advising & supporting the project.

The peer workers have been guest speakers at Bendigo Have A Say, New Horizons and SARU Management Group. They have also led Skills Workshops for Reinforce members.

Royal Commission

We received funding from the Royal Commission into Violence, Abuse and exploitation of People with Disability. As a response to the Royal Commission, we made a training film. Our hope is to build strong self advocates so these things will never happen again.

Our film is called:

OPA

Reinforce received funding from Office of the Public Advocate to work on a health project that helped doctors and nurses understand people with disabilities.

SMG

Reinforce is represented at the SARU Management Group by Norrie Blythman & James Teekan.

International Self Advocates Meeting

We had 2 meetings with People First Keighley & Craven, from the UK.

It was great to be able to share experiences with another self advocacy group.

Self Advocacy Big Issues

At our regular Members Get Together Meetings we talked about these topics and wrote letters to government asking for change.

NDIS

In June, Reinforce held an important meeting about NDIS assessments. Members SPOKE UP against independent assessments. Reinforce told the Government that we did not want the changes to NDIS assessments!

Transport

In August, Reinforce held an important meeting. We talked about transport. Members SPOKE UP about accessibility and safety on transport.



Covid-19

Reinforce ran two big meetings about Covid-19 in September and October. Members SPOKE UP about QR Codes, Vaccine Certificates and making sure people with intellectual disabilities are not being left out! Members wrote a letter to the Victorian Government about lockdown and opening up.

Why does Reinforce need an Audit?

Reinforce has a lot of money at the moment because of the ILC project so Reinforce needs to have our finances audited. Reinforce is also a registered charity so we need to follow the rules the government make for charities. The person who does the audit is called auditor

What do we pay the Auditor to do?

The auditor has 2 jobs we pay him to do:

- 1. To check that Reinforce are doing our finances correctly.
- 2. To make a report the talks about our finances in a way that shows we have followed all the rules made by the government.

The report we got back from the Auditor has 4 main parts.

Part 1: The Balance Sheet

"Money We Have and Money We Owe"

The **Balance Sheet** is part of the audit report. Brenda worked out the balance sheet at the end of the financial year and showed it to the committee before sending it to the auditor.

The Balance Sheet shows 2 things:

- 1. The money Reinforce has
- 2. The money Reinforce owes to other people.

This is the balance Sheet at 30th June 2021.

This Balance Sheet shows Reinforce had \$395,626.84 in the bank on the 30th of June 2021 and we had \$361,169.22 of money we would we need to pay. This means that Reinforce can afford to pay all its bills.

Part 2: The Statement of Equity "The Money Left over"

The next part of the report is the **Statement of Equity**After we have paid the **\$361,169.22** for our bills we would have **\$34,457** left in the bank. This amount left in the bank is called **equity**.

The report shows Reinforce have \$447 less equity than last year. This means more money was taken out of our accounts than went in. This is because New Wave took \$447 out of their account and did not put more money in.

Part 3: The Statement of Cash Flow "How Much Do We Have to Spend"



The next part of the report is the **Statement of Cash Flow**This statement gives us an idea of how much money Reinforce have available to spend right now.

Reinforce's **assets** are all money in bank accounts or term deposits and that is what the auditor calls cash. An example of an asset that is not cash would be something like a car because we would have to organise to sell the car before we had money to buy something else.

So, this part of the report is not really useful for us because it does not give much new information from the balance sheet since we do not own other kinds of assets. However, it does tell us how much cash we have available.

The statement says we have \$391,754 cash.

This is the same as the money in our bank accounts shown on the balance sheet.

The total is smaller than the total of our **assets** on the balance sheet because it does not include the money owed to Reinforce.

Part 4: Statement of Profit or Loss "Income minus Expenditure"



This part of the report shows the different ways Reinforce got and spent its money from **1st July 2020** to **30th June 2021**




